Since the 2018 assessment is not included in BK, we can file for a relief from stay and demand payment on the whole outstanding amount. Approximate cost is \$1000.

 - iii. Case 201606 Currently paying \$50/month. Current balance is \$1901 (includes 2018 assessment/late fee.)
